



Application Instructions for Contractor Financing

Contractor Registration:

- Submit completed Contractor Registration Form to your CASH COW Representative. All appropriate fields must be completed and signed
- Once your registration is reviewed and approved, your company will be assigned a Dealer Number and you will can proceed to submit your qualified clients loan applications and supporting documents

Contractor Client Qualifications:

- Client must own property and will be verified as so. The same property must be listed on application (even if not occupied by the Client). Does not need to be the same property that the loan is being requested for
 - No title search or appraisal is required
 - No equity is required
 - No collateral is required
 - No liens or UUC's required
- Client must have a credit score of 550 or Higher

Client Loan Application:

- Submit completed loan application (all appropriate fields must be completed) along with the following required documentation...
 - A current, clear copy of applicant(s) photo identification
 - A current detailed estimate from contractor(s)
 - Other documents may be requested, including Income verification's
- Once all completed documentation is submitted as required by Contractor or your CASH COW Representative a credit report will be checked and analyzed. A credit decision will be determined within a maximum one (1) business day (24 hours) after the credit application is submitted by the Contractor to Company (a business day is inclusive of Saturday).
- CASH COW Partners V will outline Finance Amount Approved for in addition to Net Funded amount, as well. If credit approved, loan documents are generated (electronically or hard copy) and sent to Applicant.
